President's Foreword

Welcome the annual report for 2023-24 for the Indian School of Development Management (ISDM). This report outlines some of the remarkable highlights from our journey of 2023– 2024 towards mainstreaming the profession and discipline of Development Management. We extend our heartfelt gratitude to all our donors, partners, faculty members and supporters for their invaluable contributions. Over this 8year journey since inception, ISDM has evolved multiple solutions to bridge gaps in Talent, Knowledge, and Practice for establishing an ecosystem for Development Management focused on transforming the lives of millions of people living on the margins of society.

We've calibrated the curriculum of our flagship Post Graduate Program in Development Management to perfection. The PGP DM is getting popular, the interest that we receive from prospective students and organisations willing to hire from us is a testimony for the same. In 2023-24 we onboarded the 7th batch of our PGP, the largest and most diverse batch till date - 91 students from across 22 States and Union Territories in the country. We've worked on keeping our quality high and fees affordable, ensuring that PGP DM remains a cost-effective choice in comparison to similar programs offered globally. When we conceptualised our flagship program, we wanted to make social sector careers aspirational, and today we have made valuable progress towards this ambition with our students experiencing significant increase in their earning potential and employability post the program (Average Salaries INR 6.7 lakhs per annum, the highest salary at INR 15 lakhs PA for (6th batch), 68% increments).

The diversity of the class has been a powerful enabler in preparing students to become authentic development management professionals. Like I always tell the students that we learn the most from people who are least like us. With above 50% women students, we're truly contributing to an inclusive and vibrant management workforce for the social sector and to SDGs on Quality Education and Women in Managerial & Leadership positions. A brand-new world is shaping up with extraordinary new opportunities, and it is our mission to make these opportunities relevant for the social sector. We have consciously prioritised the focus on our research and practice work over the last couple of years. The Global Knowledge Hub (GKH) at ISDM picked on critical pieces that have forever stunted the impact of the social sector. Our Centres of Excellence (CoEs) and Innovation Labs on Innovative Finance, Data Science and Social Impact, Philanthropy for Inclusive Development have been providing solutions to significantly increase the impact the sector could have on people and the planet.

Our capacity building and advisory work is generating revenue and entering into newer and deeper partnerships with organisations across the societal verticals of samaj, sarkar and bazaar. One of the most inspiring milestones over the last year has been achieving the 100 women mark though our Women on Boards program where we prepared and placed 100 accomplished women from the world of business on Advisory Boards of Social Purpose Organisations (SPOs).

We also organised the first ever national conference on Management for Social Change called Dialogues on Development Management. This turned out to be one of the biggest conferences in the sector and was attended by 800+ delegates from across the spectrum of State, Market, and Society, from 28 states and union territories in the country.

The leadership team at ISDM have drawn up a future-ready Project Chandrayaan to catapult us towards our mission that is rooted in the belief that a thriving social sector is essential for a just, equitable, humane, and sustainable society. This vision extends beyond borders, aiming to make ISDM a global leader in Development Management.

We're nearing completion of our vision of a state-of-the-art campus for our PGP DM, housing all current and future initiatives, embodying excellence in Development Management. After 8 years of foundational work, I truly believe that ISDM is poised to become an institution that not only pioneers the domain of Development Management but will also make a difference to hundreds of millions of people and the planet for generations to come.

Progress & Outcomes in 2023-24

Post Graduate Program in Development Management (PGP-DM)

ISDM's PGP-DM is a unique 11 month academic program focused on creating empowered development leaders who can respond to the dynamics of the social sector in India and push sustainable impact at scale.

The 6th Batch (63 students) graduated in June 2023 and we welcomed the 7th batch on July 21, 2023. With 91 students from 22 states and UTs, speaking ~46 dialects and languages, it embraces diversity and reflects a vibrant mix. They bring varied sociocultural-economic and educational backgrounds, with an almost equal mix of experienced freshers and individuals. Gender-wise, it's 40% male and 60% female. Many students have inspiring stories of transformation, coming from all parts of the country.

Placements

The Class of 2023 achieved 100% placement, with students of the Cohort finding opportunities in organisations of their interest. Offers were made by ICICI Foundation, Dr. Reddy's Foundation, The Antara Foundation, Thinkthrough Consulting, Samhita, Reliance Foundation, Educational Initiatives, Lighthouse Communities Foundation, Mantra4Change, PRADAN, etc.

The highest package offered this year was INR 15 LPA; Average salary offered was 6.7 LPA; Average increment for those with work experience was 68%.





Alumni Engagement

Alumni were engaged through different events, they helped in admissions and placement processes as well. Our alumni also attended the Dialogues on Development Management (DoDM) in September 24. 3 'Guftagu', alumni meetings were held across Delhi, Pune, Hyderabad.

The Convocation of batch 6 (Class of 2023) and the 5year reunion of Batch 2 of ISDM was held on March 16 & 17, 2024 at The Energy and Resources Institute (TERI), Gurugram. The Chief Guest for the event was Ms. Poonam Muttreja, Executive Director of Population Foundation of India (PFI) & Mr. R. Venkataramani the Attorney General for India joined us virtually as the guest of honour for the ceremony. 40% of the alumni attended the event from the Class of 2019 & 85% attended from the Class of 2023, along with ISDM staff, faculty, funders, alumni, and guests of graduating students.

Program Highlights for the 7th Batch

Students went through a two-week orientation, aimed at providing an overview of Development and the need for Development Management. Students volunteered and attended the Dialogues on Development Management Event on September 20, 2023. For Realising India (RI), a two-week district immersion journey, the students were sent to 12 districts in three states—Uttar Pradesh, Rajasthan, and Madhya Pradesh. They engaged with a range of stakeholders and explored various sectors like healthcare, livelihood, and education to understand the complexities of development issues. Students worked with the information gathered from the field through Intervention Design, Development M&E, and Systems Design courses. Placement preparedness began with sessions on mock interviews, CV and cover letter writing, and numerous CEO talks. Furthermore, they gained holistic insights into organisational development and aspects of designing with sessions on Perspectives on Organisations and Design Thinking. In the Context-Based Collaborative Learning sessions, students looked at how development values, such as inclusivity, are embedded in the management of a development organisation. Students continued with Management 101 with courses such as Fundraising, Strategy for SPOs, Technology in Management, and Behaviour Change and Communication. A series of workshops and lectures kept the students engaged with social sector practitioner voices and experiences.

Strategic Capacity Building (SCB)

The SCB vertical of ISDM works with Social Purpose Organisations (SPOs) to build their foundational capabilities in Leadership & Management and with Corporates to effectively leverage their resources to address the development sector needs and bring out the much-desired change in the social space. The vertical has reached new heights in building management & leadership capabilities of socially driven organisations/professionals and is now looking at taking ISDM to the next level of financial resilience as well. These leaders boast an average of 22 years of professional experience and represent a wide array of sectors including banking, technology, media, HR, consulting, law, medicine, academia, and construction.

The Global Knowledge Hub is committed to strengthening the knowledge and practice of Development Management, through the creation, curation, application, and dissemination of knowledge. In FY 2023 - 24, GKH has delved deeper into core Development Management knowledge work on some of the most critical issues that limit the scope of social impact - lack of innovative finance instruments and structures that can bring more private capital into the sector, difficulties in assessing the real social impact of organisations, difficulties in driving evidence-based decision making using data and data science, challenges in hiring and retaining the best talent for the sector, philanthropic practice that does not drive the systemic changes required for inclusive development. Officially Launched on June 16, 2023, with 80+ participants – nonprofit leaders to social data scientists, social entrepreneurs, academicians, private sector professionals, and stakeholders from the public policy sphere. The centre aims to promote data usage in the social sector

Knowledge Institute

The objective of this initiative is to encourage a culture of impactful, accurate, evidence-based decision making for the social sector by creating a single, online data platform, hosting digitised, open-source data related to SDGs to aid research and better decision making in the social sector. We conducted user research to understand the data challenges and expectations of stakeholders, identified partners to develop the platform, and driving sectoral engagement and knowledge creation work - <u>articles and knowledge nuggets</u> (few are co-created with the CDSSI)

Mission Sahyog aims to collaboratively co-create scalable management models and frameworks, that can be customised with some contextual modifications for small Social Purpose Organisations (SPOs) operating in diverse geographies, fostering collaboration, resilience and effectiveness targeting challenges such as funding, compliance, technology utilisation, and talent acquisition. The pilot is being run in Jharkhand.

Partnership with the Blended Finance Company: ISDM initiated the establishment of a new Blended Finance Company, in collaboration with MSDF and Asha Impact. The primary focus of the company will be on the Indian blended finance market, aiming to simplify and streamline blended finance transactions. ISDM will also play the role of being knowledge partners to this company, creating the knowledge that is needed for new and simpler blended finance transactions.

Core Development Management Work

Talent Management for the Social Sector: Following the launch of the seminal study on <u>Talent Management in the Indian Social Sector in 2022</u>, we have worked on 8 case studies for SPOs and facilitated an online workshop for the SPO partners of ATE Chandra Foundation to unpack the components of compensation compiled as part of the Talent Study. Also curated a track on Talent and Leadership in DoDM (Dialogues on Development Management – ISDM's annual conference).

Special Initiatives

The Digital Library at ISDM (NatWest Library)

ISDM achieved yet another milestone with the official launch of the NatWest Library in June 2023, a first-of-its-kind Digital Platform designed for SPOs. This unique platform offers SPOs access to a comprehensive collection of open-access and subscribed content, including databases, newspapers, journals, and eBooks, all accessible through a single-access portal, free of charge.


